2023 Tournament Application Information

ELIGIBILITY – The Invitational is open to male and female amateur golfers who are at least **12** years old and have not reached their **19th** birthday as of June 22, 2023. Entrant cannot be a member of a college golf team or have participated in any supervised team activities. All applicants must conform to the USGA Rules of Amateur Status and meet the requirements of the USGA Gender Policy. Each entry must be approved by a parent or guardian. All entry forms are subject to approval or rejection by the tournament committee at any time before or after the start of play. The reason for rejection may include conduct unbecoming of a participant (see CONDUCT CODE below).

FIELD – The field may be limited by the tournament committee to a maximum of 60 contestants *Note: 18 Hole Shotgun Start. The tournament committee shall determine the players who are exempt into the field in accordance with the exemption categories listed below. Eligible players must submit a completed entry form, including a golf resume, with the application fee.

Tournament Divisions

- Player Division (A): 12-14 Girls Division (*Note: Competitive players under the age of 12 are eligible to compete)
- Player Division (B): 12-14 Boys Division (*Note: Competitive players under the age of 12 are eligible to compete)
- Player Division (C): 15-17 Girls Division (*Note: Rising High School Seniors over the age of 17 are eligible to compete)
- Player Division (D): 15-17 Boys Division (*Note: Rising High School Seniors over the age of 17 are eligible to compete)

Entry Procedure

- 1. All entries must be submitted online at www.mymyfoundation.com. Late, incomplete, or inaccurate entry forms will not be accepted. There is a \$25 application fee for all applications.
- 2. The application fee of \$25 (credit card payment submitted online) must accompany each entry.
- 3. All entries and application fees of \$25 must be submitted online prior to 9:00PM (EST) on Sunday, May 28, 2023. Only one entry may be filed per player.
- 4. If an entrant withdraws for any reason after 9:00PM (EST) on May 28, 2023, **no refunds** will be given. If you cannot compete and do not officially withdraw **prior** to the tournament, you will be treated as a "no-show" and will be subject to exclusion from future MY MY Foundation, Inc. National Junior Tournament events.
- 5. Upon acceptance into the tournament field, the balance of the entry fee (\$185) credit card payment submitted online must be paid to confirm each applicant's acceptance into the event by 9:00PM. (EST) Sunday, June 25, 2023. Each applicant who is accepted into the field will be sent a link to make a payment on the remaining balance of \$185.

TOURNAMENT ACCEPTANCE –All players applying will be emailed notification of their status by 9:00PM (EST) on Tuesday, May 30, 2023.

FORMAT – The Kamaiu "MY MY" Johnson High School Invitational National Junior Golf Tournament is a 36-hole stroke play competition.

REGISTRATION – All players **must** register on Friday, July 21, 2023 from 4:00PM to 6:00PM (EST) or Saturday, July 22, 2023 from 9:00am - 11:30am. If you cannot register during these time, you **must** make prior arrangements by notifying the tournament staff in advance by emailing contact@mymyfoundation.com. Failure to register **will** result in your entry being withdrawn. Late registration, **with prior approval**, will be available upon your arrival. Tournament staff must be notified in advance of your request for late registration.

PRACTICE – Bear's Best Atlanta will be available for practice Friday, July 21, 2023 for all participants. Approximately one month prior to the tournament, contestants will receive an email with step-by-step instructions to secure their practice round time online.

CADDIE POLICY – Player family members and friends are permitted to caddie for contestants. The Kamaiu "MY MY" Johnson High School Invitational National Junior Golf Tournament is a walking event. Bear's Best Atlanta will have a limited number of golf carts available spectators only. Spectator carts will be offered on a first come, first served basis at a fee of \$35 plus tax per cart. Any spectators with disabilities or any

special needs may contact the Club in advance to reserve a spectator cart. Personal carts are prohibited from use at the Club.

CONDUCT CODE – The following actions by players or caddies will be considered violations of the Conduct Code: any abusive language, club throwing, cheating, disrespect of volunteers or officials, abuse of the course or clubhouse, leaving the course during your competitive round without permission from a tournament official, any use of or association with drugs or alcohol, not adhering to the dress code during any portion of the tournament, any vandalism at a host hotel, and/or any other conduct not becoming of a tournament competitor. The penalties for Conduct Code violations, based on the severity of misconduct, may be any or all of the following: a warning, disqualification of the player from the tournament, suspension of the player indefinitely from future MY MY Foundation, Inc. Tournament events.

PLAYER DRESS CODE – Players and caddies may wear golf/Bermuda style shorts or pants during the practice round and all rounds of the championship. Collared shirts must be worn during all phases of the tournament. Players in violation of the dress code will not be permitted to start the competition. A violation of the dress code by a player during the stipulated round must be rectified without undue delay or the player will not be allowed to continue play. Proper dress code is always required while at the host facility, including in the clubhouse and at all practice facilities before and after play.

FOOTWEAR – It is a condition of the competition that shoes with metal or traditionally designed spikes are prohibited. Penalty for breach of this condition: **Disqualification**.

STARTING TIMES & WEATHER – Pairings and starting times for both competition rounds will be posted on the online one week prior to the tournament. Event will go ahead in all reasonable weather conditions. Postponement or cancellation due to extreme weather conditions will be a decision made jointly by the Tournament Director and Host Club. If necessary, this tournament may be decided on a reduced number of holes played if extreme weather causes cancellation of all or part of a round. The tournament winner will be announced on Sunday, July, 23, 2023 and the event close will not extend beyond this date.

RULES OF GOLF – The Rules of Golf as approved by the USGA govern play. The tournament committee reserves the right to alter any of the conditions and schedules herein. Changes in tournament format caused by force majeure shall be within the sole discretion of the tournament officials. The decisions of the tournament committee in any matter shall be final.

PACE OF PLAY – The Kamaiu "MY MY" Johnson High School Invitational National Junior Golf Tournament uses a 4 Checkpoint System as an integral component for its Pace of Play Policy. Players are expected to complete each Round within a specified time allotment, including meeting each of the 4 checkpoint hole time requirements. Pace of play targets are printed on each players' scorecard and the 4 checkpoint holes are identified on the teeing area of each checkpoint hole. Players failing to meet the Pace of Play Guidelines are subject to penalty per the policy. The Pace of Play Policy is reviewed with each player at player registration. Players are expected to have read and understood the Pace of Play Policy prior to commencing tournament play.

TRAVEL TRANSPORTATION AND ACCOMMODATIONS - Upon notice of tournament acceptance, participants should book flight reservations into Atlanta Hartsfield-Jackson International Airport (Approx. 46.4 miles from Bear's Best Atlanta) The host hotel will be emailed and posted on the MY MY Foundation, Inc. website to secure a nightly group rate.

PUBLICITY AND PROMOTION; BROADCASTING - By submitting this application, I understand that the MY MY Foundation, Inc. or its designees, may record, film, photograph, or otherwise capture my likeness, image, voice, biography, references to me, my quoted statements, and my play in the Championship (the foregoing, together with my name, my "Appearance"). In consideration of the opportunity to participate in the National Junior Invitational Golf Tournament, by submitting this Application, I grant (and/or have the authority to grant to the MY MY Foundation, Inc. in the case of a parent/guardian of a minor or other authorized representative submitting the Application on my behalf) to the MY MY Foundation, Inc., and its licensees, successors and assigns, the perpetual, transferable, assignable, worldwide, royalty-free, irrevocable right to use my Appearance, in whole or in part, in all manner (including exhibition, distribution, reproduction, publication, display, broadcast, transmission or otherwise), and media now known or hereafter invented or discovered, and for any purpose whatsoever. The rights granted herein include, without limitation, the right to use the Appearance, or portions thereof, in promotion of the National Junior Invitational Golf Tournament and future tournaments through any of the foregoing means of distribution. as well as in the design, manufacture and distribution of merchandise related to the National Junior Invitational Golf Tournament or other tournaments, that include

elements of my Appearance. The MY MY Foundation, Inc. is not obligated to use my Appearance in any matter, and materials embodying any aspect of my Appearance do not need be submitted to me for approval. I release and discharge the MY MY Foundation, Inc., its licensees, successors and assigns from any claims arising from use of my Appearance, including claims for misrepresentation of me, my character, or my person by any means. As between the MY MY Foundation and me, the MY MY Foundation shall own all right, title and interest, including the copyright(s), in and to any works created by the MY MY Foundation, Inc., its licensees, successors and assigns, that include all or a portion of my Appearance. This grant shall be binding on my heirs, executors, administrators and assigns, and the successors and assigns of the MY MY Foundation, Inc. I hereby waive all privacy, publicity, defamation, libel, and proprietary rights relating to the Appearance as used by the MY MY Foundation, Inc. in conjunction with these terms. Players are required to cooperate with representatives of the media; however, no pre-tournament activities outside of those activities which are part of the National Junior Invitational Golf Tournament will be required. Authorized representatives of the media will not interfere with the player's National Junior Invitational Junior Invitational Golf Tournament play in an unreasonable manner.

SPECIAL NOTE: The field may be limited by the tournament committee to a **maximum of 60 players**. Those not originally accepted into the 60 player field may become alternates.
